Town of Cadiz Fireworks Permit Application

Wisconsin Statute 167.10 prohibits the use or possession of fireworks, as defined under 167.10(1), without a user's permit issued by the mayor of a city, president of a village or chairperson of a town in which the possession or use is to occur. Permits can only be issued to one of the following: 1) a public authority; 2) a fair association; 3) an amusement part; 4) a park board; 5) a civic organization; 6) any individual or group of individuals; 7) an agricultural producer for the protection of crops from predatory birds or animals. NOTE: Permits cannot be issued to a minor; they must be 18 years of age, under 167.10(3)(h). A copy of this permit shall be on file with the clerk of the city, village or town.

The permit holder will be responsible for emailing a copy of the approved permit to the Green County Sheriff's Department and the Browntown, Cadiz, and Jordan Fire Department at least 72 hours prior to the date of authorized use of the listed fireworks.

Any approved permit is void if a burning ban is issued for the Town of Cadiz/Green County during the requested date(s).

- 2. The clerk will inform the town chairman upon receipt of the permit application.
- 3. The class of firework and approximate quantity to be fired must be included on the form. Federal law requires all consumer class fireworks to be labeled with appropriate rating.
- 4. Upon approval, the Fireworks Permit will be e-mailed to the email address on the application. If no email address is included, the permit will be mailed to the address on the application, unless other arrangements are made by the permit holder.
- 5. **At least 72 hours prior to deployment**, a copy of the permit must be <u>emailed</u> to the following three (3) email addresses:

In the event of a fire or other emergency, call 911.

Permit is void if a burning ban has been issued for the Town of Cadiz/Green County during the requested date(s).

Any fireworks that have been deployed or that are thought to be duds are to be picked up but are NOT to be placed inside of a garage or other building due to the risk of fire.
